### President's Message



We have had a busy fall and winter season. The flights committee held a Back to the Slopes party outdoors at the Shipgarten in McLean, VA last fall. The event was accessible via metro and there was parking available nearby. It attracted 135 participants. This fall, we had another successful weeklong golf trip to Hilton Head Island in November. The trip to Punta Cana with Club Med was postponed to December 2022 due to hurricane damage in the fall. The trip was very successful.



**Using University Blvd to enter** = address is 3950 University Blvd and garage entrance 20 yards from this address, it is visible from the street. Coming in this way, park on the third floor and exit out the front door to Chain Bridge, turn left, cross North St. and proceed to the restaurant. With heavy traffic on Chain Bridge, this is the best entrance to use. Enter this address into your smartphone driving app.

There is an outside entrance that will take you directly into the party room, called the "Cellar."

### SKIING
