To Ski or Not to Ski

That is the question on many SCWDC member's minds when they reminisce about the shortened 2020 season, dream about the 2021 ski season and yet wonder if it is possible in the time of Covid19 and social distancing. After much deliberation and negotiations with ski destination suppliers, SCWDC has decided to plan for a 2021 ski season. There is no doubt skiing and traveling will be different in 2021. While the destinations will be familiar, exciting, and interesting, they will occur in a still evolving "new normal."

SCWDC is committed to offering, to the best of its ability, safe and enjoyable ski vacations, and other experiences. Skiing and traveling have always had inherent risks, but the presence of Covid19 adds another layer of risk. SCWDC members and guests will need to make their own informed decision whether To Ski or Not to Ski. SCWDC encourages each member to evaluate their level of comfort and risk.

We have got your back with our Go/No-Go Decision Date: August 28, 2020. If you decide to cancel by the Go/No-Go date, you will receive a full refund for any trip payments you have made. The no-risk sign-up period begins July 1, 2020 through August 28, 2020. Beginning 29 August 2020, the cancellation fee is \$50, plus all unrecoverable expenses if a replacement is not found. Also, all our trips have Covid19-related escape clauses to ensure refunds in the event of any pandemic related closures or interruptions prior or during our trips. However, this year we strongly suggest that you obtain FULL Trip Cancellation Insurance within 14 days of sign-up to allow you to cancel your reservation for any reason at any time before and during the trip. (We will also be offering our standard travel interruption insurance again this year for \$25.)

The Anticipated SCWDC Ski Trip Experience, What to Expect (as of July 1, 2020.)

The evolving "new normal" will impact the 2021 Ski season in different ways, depending on the jurisdictions and airlines. They may include but not be limited to:

- Air travel
- Additional time needed to pass through airport security (TSA)
 - Lines will be longer due to social distancing
- Preflight health questionnaire prior to checking in
- Additional TSA questions
- Addition of thermal testing
- Face covering (mask) is likely to be mandatory while in line for TSA security area
- Boarding passes with cellphone QR code or printed out at home
- No guarantee that planes will provide social distancing
- mandatory wearing of face covering while onboard
- no in-flight food or beverage service, no snacks
- On long-distance flights, there will likely be no blankets, pillows or headphones handed out
 - Entertainment is likely to be from personal WiFi-enabled electronic devices
- Social distancing required in lounge area, baggage claim
- Ground transfers
- Luggage handling (uncertain)
- Social distancing may be required on private coaches or lodging-provided shuttles

SKIING

- Lodging, food service
- Singles must be willing to share a double occupancy hotel room with another club member who is not a significant other, or opt for a single supplement
- Condo space will be shared by other club members who are not significant others or household members
- Breakfast buffets, where included, may be grab and go, or server-assisted buffet lines
- Dining rooms may follow reduced seating capacity, in accordance with local social distancing rules
- There may not be seating or congregating at bars

On the slopes

- lift lines will be different due to social distancing policies
 - singles may occupy their own chair on double or triple chairs
 - singles may occupy opposite sides of quad or six-pack or larger chairs
 - Gondolas capacity likely to be reduced
- Slope capacity may be limited
- Food service may be limited

Ski resorts and enthusiastic/passionate skiers/snowboarders will find a way to have a ski season, restrictions notwithstanding. An early example is the reopening of A-Basin in May of 2020 during the ongoing pandemic:

The “new normal” will vary from destination to destination, as dictated by local jurisdictions, and by the airlines.

All the above is subject to change as we get closer to departure time. Each trip leader will keep their trip participants informed of status at resorts.

Please note that the prices listed in this table are subject to change. The SCWDC web will contain the current price.

1: All trips are being priced without lift tickets because many ski resorts now offer "MEGA" passes, the option to buy a season long ticket to ski at multiple locations which honor this particular kind of ticket. The primary "MEGA" passes are termed Epic and IKON. The SCWDC website states which trips are associated with each kind of pass. The commercial marketplace objective is to provide discounts to frequent skiers and to attract those skiers to certain resorts. All our trips allow for discounted, group lift ticket purchases, but there is a minimum number of lift ticket sales that are required to obtain the discount. In most cases that number is 20 lift tickets, and in a few cases, it is 25. This means that SCWDC passes on the whole discount that we obtain from the tour operator buying group-price tickets. If this group participation is less than the lift ticket minimum, then the SCWDC must charge you for the full price of the tickets.

2: "Ground Only" is the option for skiers to make their own airline reservations to the destination airport nearest the ski resort. Every person who takes this option must sign an acknowledgment, that this makes them responsible for a possible charge, if you have to cancel, you are responsible for allowing the club to buy another ticket for your replacement at the going rate available from the airline. You are also responsible to meet the SCWDC-designated transportation at the destination airport, by the time the transportation vehicle is ready to leave. We do not hold the transportation vehicle for your late arrival.

3. "Single Supplement" means that you purchase at our cost, the right to occupy a bedroom without a roommate. All our trips are priced based on double occupancy of every bedroom, whether the bedding is a single bed like a king or queen, or two twin beds suitable for two singles of the same sex. Our tour operators provide us the cost of this arrangement and we add other cost factors that we would have earned if the single supplement had not been sold. Our trips help us earn the income that we need to pay for SCWDC overhead expenses.

4. Airline arrangements made by the club at the beginning of the ski season are subject to change, based on airline route changes in schedules as well as the opportunity for the club to switch to an airline offering a cheaper price or not charging luggage fees. Therefore, persons who choose to make their own reservations, termed "ground only", are asked to sign an acknowledgment that they have chosen to make their own arrangements and bear the risk of any disconnect between the club transportation and the skiers' own travel arrangements.

EASTERN SKI TRIPS 2021

You may still be hiding in your basement and avoiding human contact, but a vaccine and cold weather & snow are just around the corner! We have been busy this summer planning ski trips in anticipation of a great ski and snowboard season in the east!

Below is a tentative 2021 eastern schedule. This schedule will also be available on the Web site soon! Registration links for each trip will then be accessible via the Club's website.

At this time, our one-day trips are awaiting approval from Vail Resorts which has acquired all three of our nearby Pennsylvania ski resorts. But remember, trips may be cancelled if registrations do not occur by contract deadlines so register early so you do not miss out! See you on the mountain!

Therefore, the departure and return airport are subject to change, along with times of departure and return. If you want to use frequent flyer miles, your own carrier and schedule, you will be responsible for the transportation to the ski destination if you cannot connect with the SCWDC transportation arrangement. We do not hold our group departure from the airport to the resort to wait for a late-arriving participant. **Snowfall totals** are historical and cannot be guaranteed for any year. **Reservation Policy:** Spaces are not held until you sign up for the trip and make a deposit, and you receive an email acknowledgment from our website.

TENNIS

To be assured of a playing spot on a particular Tuesday evening, contact the leader, Trish Mast Russell at trishymast@icloud.com or 202.286.5352. You can still drop in without giving advance notice, and you may be able to play if spots are available. The participant's cost is based on the cost of court reservations (fees paid to Fairfax County for court rental). So, when you see this in September, check in with the leader for Fall tennis play. The easiest way is to write an email to Trish and state your playing ability (intermediate or advanced player), and how often you play now. Trish tries to arrange matches suitable for every player's ability level.



Indoor Tennis Parties (Best Deal in Town)

Ski Club Indoor Tennis parties are held almost every Saturday night from October through April. Tennis parties provide competitive social doubles and mixed doubles, where players enjoy good tennis, mingle, and enjoy a light buffet and beverages.

Who is eligible to attend?

Parties are for adults over 21 years of age who are experienced intermediate players (NTRP 2.5 to 4.5 or higher). If you are not sure of your numerical rating, please review the USTA's National Tennis Rating Program (NTRP) guidelines, (to discuss your level, contact Jack Tarr, jtarr5@verizon.net). Attendance is typically a mix of active singles and couples from their late 20's to 60's. Parties average 64 players each week, but some have up to 80 in attendance. Male/female split is close to 50/50 at each party. Newcomers and non-SCWDC members are welcome. Non-players are also welcome, just pay \$10 on-line or \$15 at the door and you can eat, drink, and socialize.

Our plans for the Ski Club tennis parties in 2020: the remaining tennis parties scheduled for October, November, and December at Fairfax Racquet Club and the October and January parties at Georgetown Prep Tennis Club are canceled because of the restrictions, (limited capacity, social distancing, and frequent cleaning) in both clubs due to COVID-19.

We do not feel comfortable asking players to volunteer or participate in a social tennis gathering. We will re-evaluate later in the year to determine how to proceed in 2021.
